No:GAB-7/2016/57: The Governor of Meghalaya is pleased to amend the Meghalaya State Guest Rules, 1991 as follows:-

- 1. Short title and commencement .— (1) These Rules shall be called the Meghalaya State Guest (Amendment) Rules, 2020.
- (2) They shall come into force with immediate effect.
- 2. **Amendment of Rule 10.—** (a)The existing Rule 10 of the Meghalaya State Guest Rules, 1991, shall be substituted as follows:-

"The period for treating a dignitary as State Guest shall ordinarily not exceed seven days".

3. **Amendment of Rule 10 (A).**— (b) The existing Rule 10 (A) of the Meghalaya State Guest Rules,1991, shall be substituted as follows:-

FORMER GOVERNORS, FORMER CHIEF MINISTERS OF THE STATE OF MEGHALAYA, RETIRED CHIEF JUSTICES AND RETIRED JUDGES OF THE MEGHALAYA HIGH COURT

"State Guest Status may be accorded to former Governors, former Chief Ministers of the State of Meghalaya, retired Chief Justices and retired Judges of the Meghalaya High Court with accompanying spouse and two other dependent members of family during their visit to Meghalaya Houses at Kolkata and New Delhi".
