CONDITIONS OF ELIGIBILITY

AGE & AGE RELAXATION -

Age will be calculated with reference to **01.01.2026** and should have attained the age of **18 years to 32 years**. Upper age limit is relaxable by 5 years for SC/ST.

No age bar in respect of regular Government Employees who entered Government service within the prescribed age limit.

- The Date of Birth to be accepted by the Department is as entered in the Matriculation/Secondary School Leaving Certificate/ or a Certificate recognized by an Indian University as equivalent to Matriculation or an extract from the official registers duly Certified by the proper authority of the Board of School Education. Documents other than these will not be accepted by the Department.
- No other document relating to age like horoscopes, affidavits, birth extracts from Municipal Corporations, Registrar Economics and Statistics and Service Records shall be accepted.

FEE (Inclusive of Examination Fee) Non-Refundable -

Fee as prescribed in the table below is required to be paid through (i) e-Challan (ii) On-line mode using the On-line payment gateway GRAS.

SUBMISSIONM OF APPLICATION -

For candidates applying for the first time through online mode, a one-time registration process is required to enable them to apply against the advertisement posts. Kindly read instructions on the webpage before applying. Last date for online application is **31st March, 2026**.

PAYMENT OF APPLICATION FEES -

Candidates who wish to apply may pay the application fees using anyone of the following modes of payment only;

INSTRUCTION -

- 1) There shall be no Personal Interview with regards to posts at Sl.3 to Sl.8 which is in pursuance to Personnel & A.R(B) Department's O.M. No.PER(AR)58/2024/36, dated 29th July, 2025.
- 2) Applicants are advised to apply well in advance without waiting the closing date.
- 3) Applicants are advised to apply the post as per the eligible category of vacant post so as to avoid rejection of application.
- 4) Admission to all stages of the recruitment process for which the candidates are admitted by the Department will be purely Provisional subject to satisfying the prescribed eligibility conditions.
- 5) Applicants are advised to ensure their eligibility with regards to the educational qualification, age and other criteria as required in the post.
